### **Pell Lake — Bill Pavlick**

- Pavlick has been hearing rumblings about this race but has received no official confirmation whether BSOA is attempting to conduct this race in 2022.
- Homuth and Preidis report they are having difficulty “navigating the paths” set forth by BSOA.
- Homuth reports he’s receiving very little input/helpful information and has no idea who to even contact on either the Pell Lake or village of Bloomfield boards.
- Mackey suggested at this late stage to have Homuth and Preidis build the relationships and engage in the necessary discussions, but not rush to get a race date for 2022.

### **2022 Schedule — Bill Pavlick**

### **Equipment — Bill Pavlick**

- BSOA approached MRC about splitting the cost of the club truck and equipment upkeep (i.e., license registration, maintenance, repairs, insurance, etc.). The total for 2021 is \$1,217.14.
- Burdick motions to split all equipment costs with BSOA. Motion seconded by Pavlick. Vote taken was eight “yes” and one abstention. MRC will send a check for \$608.57 to BSOA to cover half of their costs.

- Still need to sort out the problems with the 15hp Mercury. Mackey will work on moving the engine south to get the repairs made.
